In the listing, we added a link to the second menu, the Process Status menu itself.

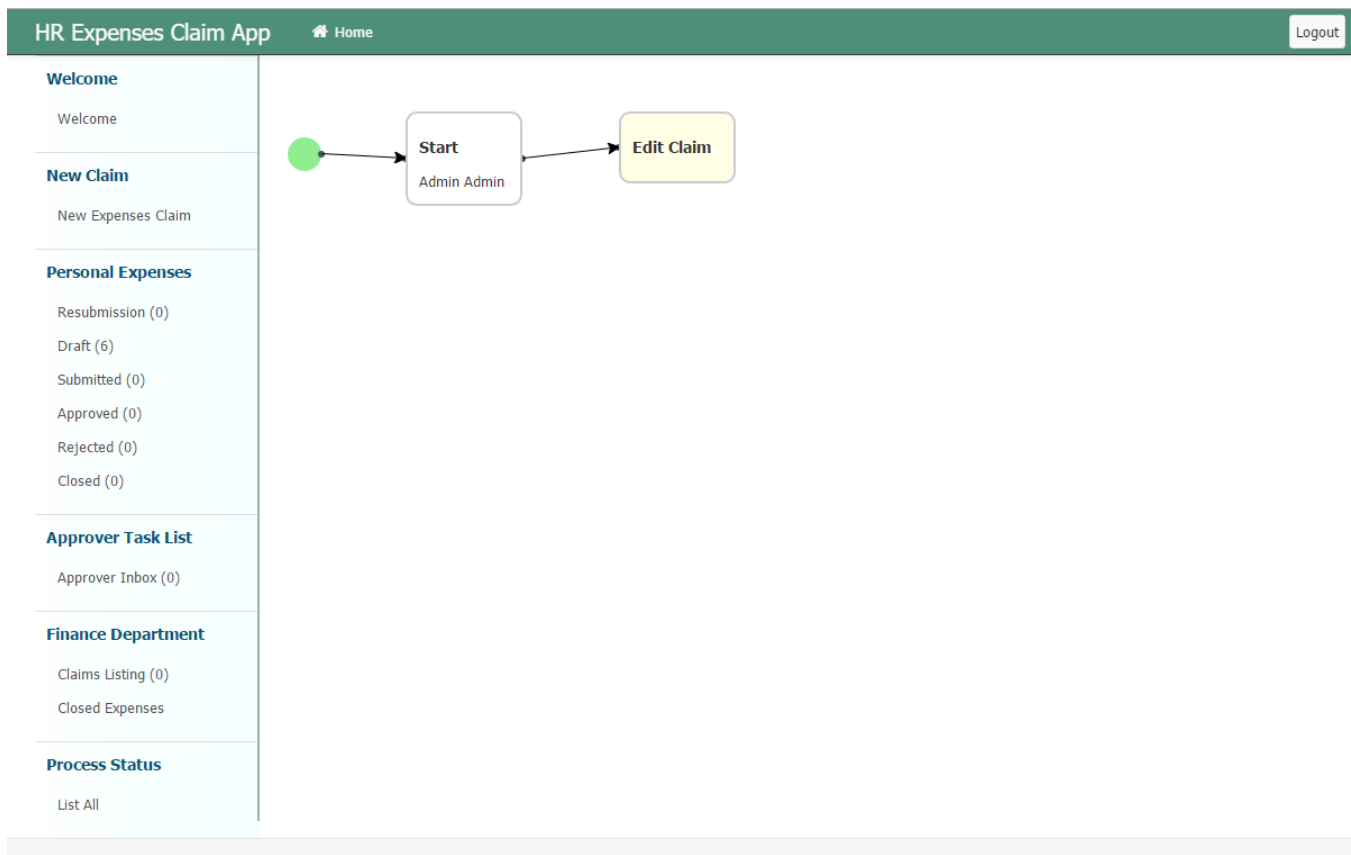


Figure 2: Process Status
